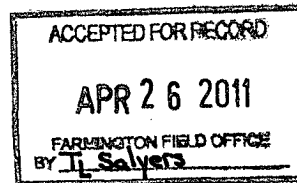

4/11/2011 Spud well @ 11:30 pm on 4/11/2011. Drill 12.25" hole to 238'. Run 5 jts. 9.625" 32.3# H-40 ST&C casing with landing jt. 240, set at 232'. RU Halliburton. Cement with 107 sks. Class G, 2% Cacl with 1/4#sk flooele (128 cu. ft.). Circulate 7 bbls cement to surface. Plug down @ 10:30 am on 4/13/2011. Float did not hold, close cement head. RD Halliburton. WOC, cut off, NU BOP. Test BOP to 250# low - 15 minutes and to 2000# high - 15 minutes ok. Tested 9.625" casing 750# - 30 minutes - ok.
