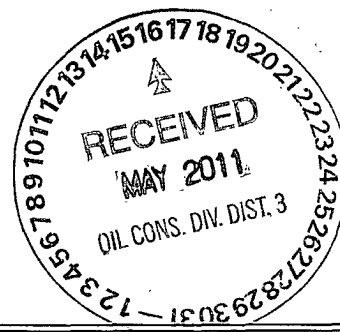

Cement with 133 sks Type V, 2% CaCl2, 1/4#/sk floccle (160 cu.ft.). Circulate 14 bbls cement to surface. Plug down @ 5:30 pm on 05/12/11. WOC. RD Halliburton. NU BOP. Test casing & BOP to 750 psi for 30 minutes - ok.
