This well was first delivered on 5/10/2011 and produced natural gas and entrained hydrocarbons.

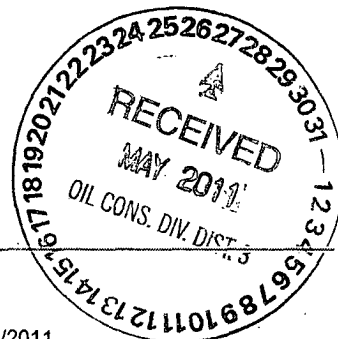
