Plug down 7:45 AM on 11-06-02. Circulate 6 bbls to surface. Drilled 7-7/8 hole to 1345' KB. TD reached 3:15 AM on 11-07-02. Ran 32-joints, 4-1/2, 11.6#, J-55 LTC casing set @ 1345.46' KB. Cemented w/150 sx Class "B", 2% Metasiklicite, 1/4# Celloflake and 170sx Class "B", 1/4# Celloflake. Bump plug w/900 PSI. Plug down @ 10:05 AM on 11-07-02 - float held. Circulate 30 bbls to surface. Rig down cementers. Set slips. Cut off casing. Release rig. Install wellhead.
