In reference to the Sundry Notice dated 7/23/02 and that was approved by the BLM on 7/28/02, due to encountering downhole problems, the Mancos at 2940' to 2950' and the Menefee at 2632' to 2637' were neither perforated.

Instead, a Mechanical Integrity Test was performed successfully ^{on 9/17/02} and was witnessed by Bruce Martin of the New Mexico Oil Conservation Division and by Johnny Angel, Pride Energy Company's engineering consultant. The well was then temporarily abandoned.
