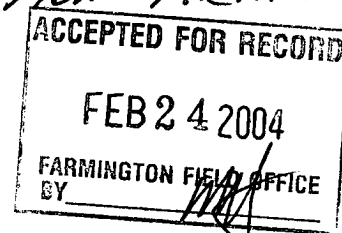
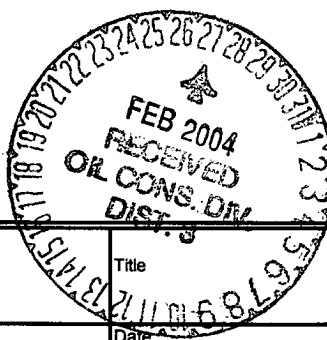

On 1/15/2004, work commenced to downhole commingle the subject well. The production tubing and Model "R" production packer were removed from the wellbore. Fill was cleaned from PBTD at 8330'. The 2-3/8" tubing was then run back in the well and landed at 8242' with no packer in hole. The well was turned to sales as a downhole commingled Mesa Verde/Dakota producer.
