Dear Mr. Hatch:

The above well was drilled in 1956 to a total depth of 751 feet. Seven inch casing was set at 542 feet. The operator reported that they had an oil show from 542 feet to 562 feet and at 738 feet. The well was temporarily abandoned and the operator stated by letter that it was their intention to move back on the well at a later date and attempt a completion. No further information was received. I, therefore, recommend that a hearing be set to have the operator and the bonding company show cause why this well should not be plugged in accordance with New Mexico Oil Conservation Commission rules and regulations.
