APPLICATION FOR SUSPENSION OF OPERATIONS AND PRODUCTION

1. Lease No. NM-53365 is in its extended term.
2. The Federal 8 #4 is the only well on the lease. The Federal 8 #4 produced 87 barrels of oil in 37 days during 1987. This averages to 2 plus barrels per day.
3. The Federal 8 #4 is a stripper well.
4. The lease is capable of production in paying quantities, but the failure to suspend production will lead to premature abandonment.

A permit to vent casinghead gas was approved by the BLM on October 1, 1987 for periods when the casinghead gas production drops below 50 Mcf per day (pool-wide).
