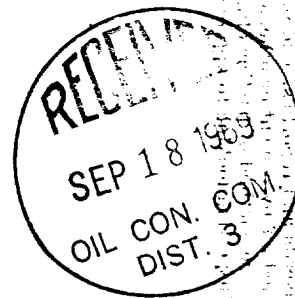

Spudded 9/7/69. Drilled to 64', ran 2-Jts of 10-3/4" 32.75# casing landed at 61', cemented W/70 sacks circulated. Drilled to 1647', logged, ran 53 Jts of 7" 20# casing landed @ 1647, cemented W/125 sacks.

Moved in completion rig, drilled out cement and drilled to T.D. of 1660'. Ran 51 Jts of 2-7/8" EUE 6.50# tubing landed @ 1640', ran 2-1/4" pump on 65 of 3/4" x 25' sucker rods. Now testing well.
