H E SHILLANDER, being first duly sworn according to law, upon his oath deposes and says:

1. That he is Agent of Roy M Eidal, Operator, whose address is c/o H E Shillander, 414½ Central S E, Albuquerque, New Mexico 87101.
2. That Roy M Eidal is the operator of a well drilled on land belonging to THE U S Department of Interior, Bureau of Land Management, whose District Office address is 3550 Pan American Freeway N E, Albuquerque, New Mexico, said well being drilled to test for hydrocarbons and/or carbon dioxide gas and described as the IGNACIO CHAVES GRANT Well Number 6, being located 2500 feet from the West line and 1775 feet from the South line of Section 4, Township 15 North, Range 6 West, NMPM, McKinley County, New Mexico.
3. That said well was drilled to a total depth of 765 feet, and that casing has been set and cemented as follows: 7" 23' to 15'
4" 9.5' to total depth and perforated
745'-747' and 732-733'
4. That operator and landowner have made an agreement whereby Operator is to back fill pits, level location, and clear it of all junk. The agreement further provides that operator is to plug said well back to a plugged-back total depth of no feet and transfer well to landowner for its use as a water well. Operator will leave all casing in the well as above. and cap with threaded cap.
5. That when operator has complied with the provisions of Paragraph 4 above he will so notify the Oil Conservation Commission of the State of New Mexico on Commission Form C-103, together with a signed statement from the landowner that the provisions of Paragraph 4 above have been complied with to his satisfaction.
