APPLICATION FOR SUSPENSION OF OPERATIONS AND PRODUCTION

1. Lease No. NM-33382 is in its extended term.
2. The Ludwick #1 is a producible well on the lease. Ludwick #3 is a shut-in well on the lease. The Ludwick #1 produced 429 Mcf in 80 days during 1987. This averages to 5 Mcf per day.
3. The Ludwick #1 is a stripper well.
4. The lease is capable of production in paying quantities, but the failure to suspend production will lead to premature abandonment.

The Ludwick #1 is a gas cap well in the Papers Wash Mesaverde Oil Pool. Production of the reservoir energy will lead to the waste of oil by leaving it in the ground without energy to move to a wellbore for production.

A permit to vent casinghead gas was approved by the BLM on October 1, 1987 for periods when the casinghead gas production drops below 50 Mcf per day (pool-wide).
