- 3. Separate drilling reports (Form C-103) should be submitted, showing casing setting depth, amount and type of cement used, top of cement and method used to determine cement top.
- 4. Separate well completion reports (Form C-105) should be submitted, including summaries of all tests conducted on the wells and any electric or radio activity logs run on the wells.
- 5. Separate requests for allowable (Form C-104) should be submitted, completely filled out.
