Merrion has recently purchased the McCollum #2 and plans to tie it to the central compression facility and purchase a compressor to accommodate the larger gas volume. Production will resume upon completion of downhole work on the McCollum #2 and upgrade of central compression facilities. Estimated completion date is October 4, 1996.
