Merrion Oil & Gas filed a sundry to plug and abandon the subject wellbore. We subsequently added additional perfs and refraced the Corrales No. 2. Results are inconclusive. We propose to add perforations in the subject wellbore and monitor production from both wells for six months to determine whether the wells are economic to produce. If the test results are unsatisfactory, we will plug the subject well according to the previously approved P&A procedure.
