Will drill 12-1/4" hole to 100 ft. Set 8-5/8", 23 #/ft, J-55 surface casing at 100 ft. with 80 sx Class B 2% CaCl2 (94.4 cu. ft.). Wait on cement 10 hours. Nipple up BOPs, pressure test to 600 PSI. Drill 6-3/4" hole to TD. If deemed necessary, will run open hole logs. Will set 5-1/2", 15.5 #/ft, K-55 production casing @ 3190' with 150 sx Class B 2% D-79 (309 cu. ft.) cement followed by 100 sx Class H 2% gel (122 cu. ft.). Estimated top of cement - surface. Perforate and stimulate as necessary to test Mesaverde.

Drilling circulating medium will be low solids, non-dispersed, low water loss mud using bentonite, starch, CMC and fresh water.

Pressure control will be 2000 PSI bag type blowout preventer.

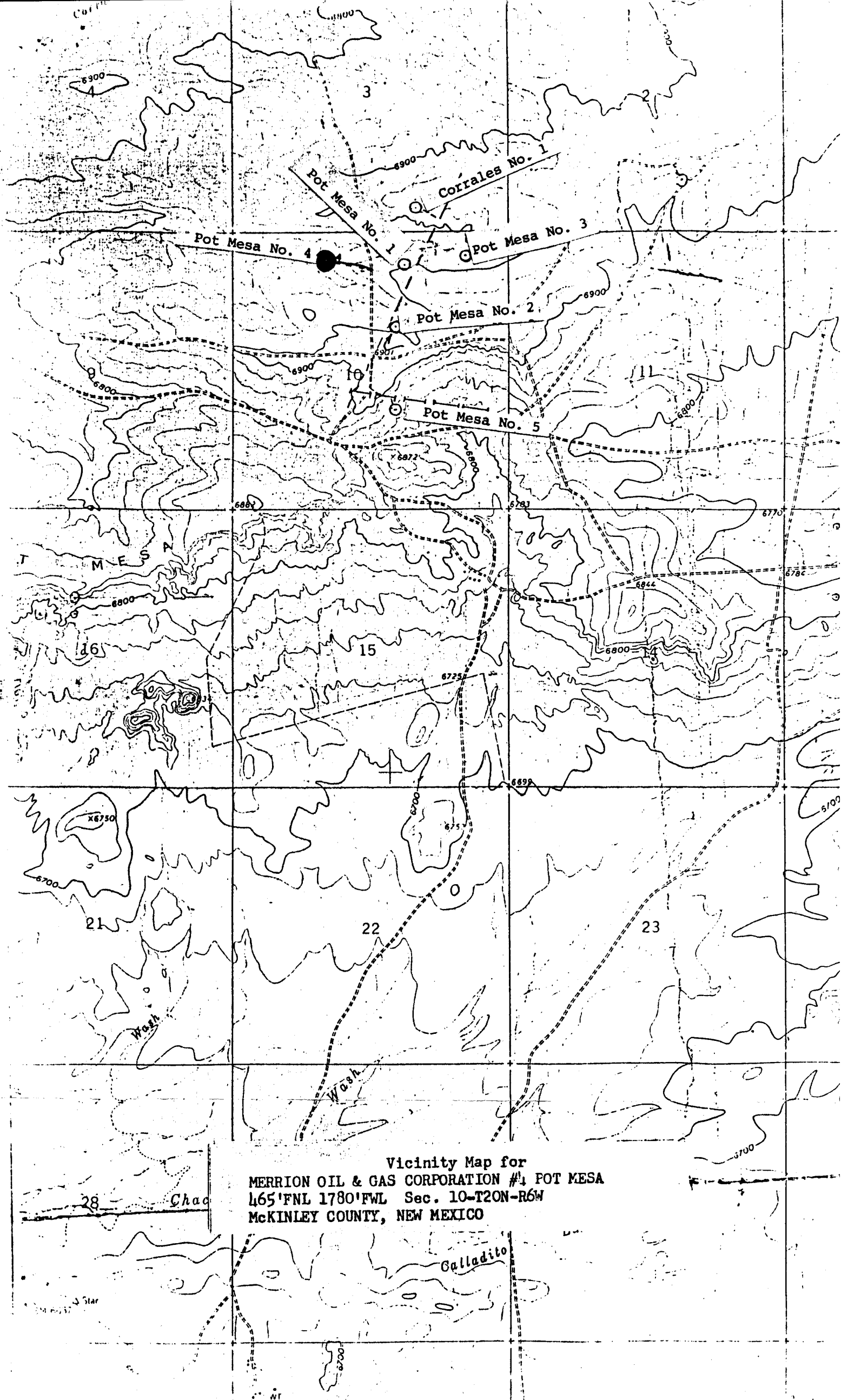
