Merrion Oil & Gas had planned to return the subject well to production by May 1, 1997. The compressor has been replaced and the surface equipment is ready to start, however, the injection pump on the Pot Mesa #2 SWD well would not start. The pump was more costly to repair than the purchase of a new pump. Delivery for the new pump is approximately 4 weeks. We therefore request that the deadline for returning the well to production be extended to July 1, 1997.
