Dear Mr. Wood:

Reference is made to your application on behalf of the operator, Limark Corporation, dated April 28 and May 4, 1998, for an unorthodox oil well to test the Entrada formation with its proposed Navajo "6" Well No. 1 (API No. 30-031-20989) to be drilled 605 feet from the North line and 1215 feet from the East line (Lot 1/Unit A) of Section 6, Township 19 North, Range 9 West, NMPM, McKinley County, New Mexico. Lot 1 (NE/4 NE/4 equivalent) of said Section 6 is to be dedicated to said well in order to form a standard 40.61-acre oil spacing and proration unit for said interval.

The geologic interpretation submitted with this application indicates that a well drilled at the proposed unorthodox oil well location will be at a more favorable geologic position within the potentially oil productive interval of the Entrada formation than a well drilled at a location considered to be standard within the subject 40.61-acre oil spacing and proration unit.

Further, all of Sections 5 and 6, Township 19 North, Range 9 West, NMPM, McKinley County, New Mexico are included within a single fee lease in which Limark Corporation is the leasehold operator; therefore, there are no affected offsets to the subject 40.61-acre tract other than Limark Corporation.

The subject application has been duly filed under the provisions of Rule 104.F of the General Rules and Regulations of the New Mexico Oil Conservation Division.

By the authority granted me under the provisions of Division General Rule 104.F(2), the above-described unorthodox oil well location is hereby approved.



REQUEST FOR ADMINISTRATIVE APPROVAL FOR NON-STANDARD LOCATION
FOR LIMARK CORPORATION'S NAVAJO 6 #1 OIL WELL
605' FNL & 1215' FEL SEC. 6, T. 19 N., R. 9 W., MCKINKLEY COUNTY, NM

- I. The well is on Navajo Tribal fee surface and a private oil and gas lease. The proposed location is non-standard (105' from the west quarter-quarter line instead of the standard minimum 330'). The APD is attached.
- II. A C-102 showing the well location and proration unit (NENE of Sec. 6 which totals 40.61 acres) and lease (all of Sec. 6 which totals 645.29 ac. and is part of a several thousand acre lease including as a minimum all of 5 & 6-19n-9w and all of 31-20n-9w) is attached.
- III. According to NM Oil Conservation Records, there is no production of any kind within a mile radius. A copy of the Seven Lakes NE 7.5' USGS map is attached showing the proposed well (triangle), spacing units (thin solid lines), and lease (thick solid line). There are only two leases within a minimum 1,357' radius. Limark is the operator of all oil and gas interests in its private lease. The next closest lease (1,357' distant) is state oil and gas lease VA-1475 which is held by Enerdyne, a Limark partner. A registered letter has been sent to Enerdyne and the NM State Land Office (see attached notice).
- IV. A copy of the composite copy of the Seven Lakes NE 7.5' USGS map is attached. The proposed well is marked by a triangle. Proration units (quarter-quarters) are marked by thin lines.
- V. Limark selected its location based on a 1997 3-D seismic survey with lines spaced at quarter mile intervals. A standard drilling window does not overlap the sweet spot of the indicated reservoir (see attached CONFIDENTIAL Entrada reflection map from the seismic survey).
- VI. No archaeology sites were found.
- VII. Surface conditions are not an issue.

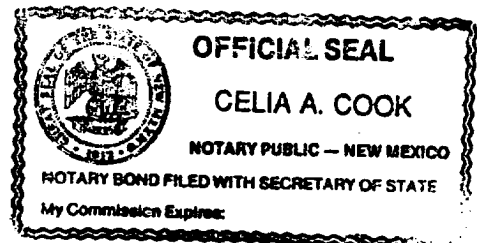
