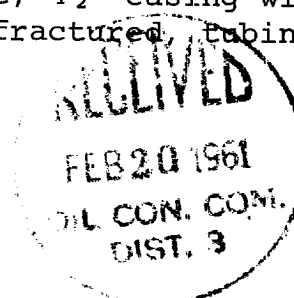

### DETAILS OF WORK

A 12 $\frac{1}{4}$ " hole will be drilled to approximately 200' and 8 5/8" 24# J-55 casing will be cemented to the surface. A 7 7/8" hole will then be drilled to approximately 5840 feet, 4 $\frac{1}{2}$ " casing will be run to total depth. The well will then be fractured, tubing run, and the well completed.



I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

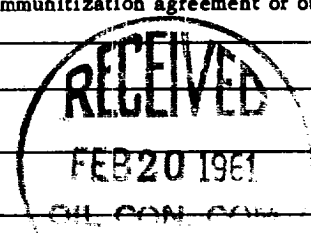

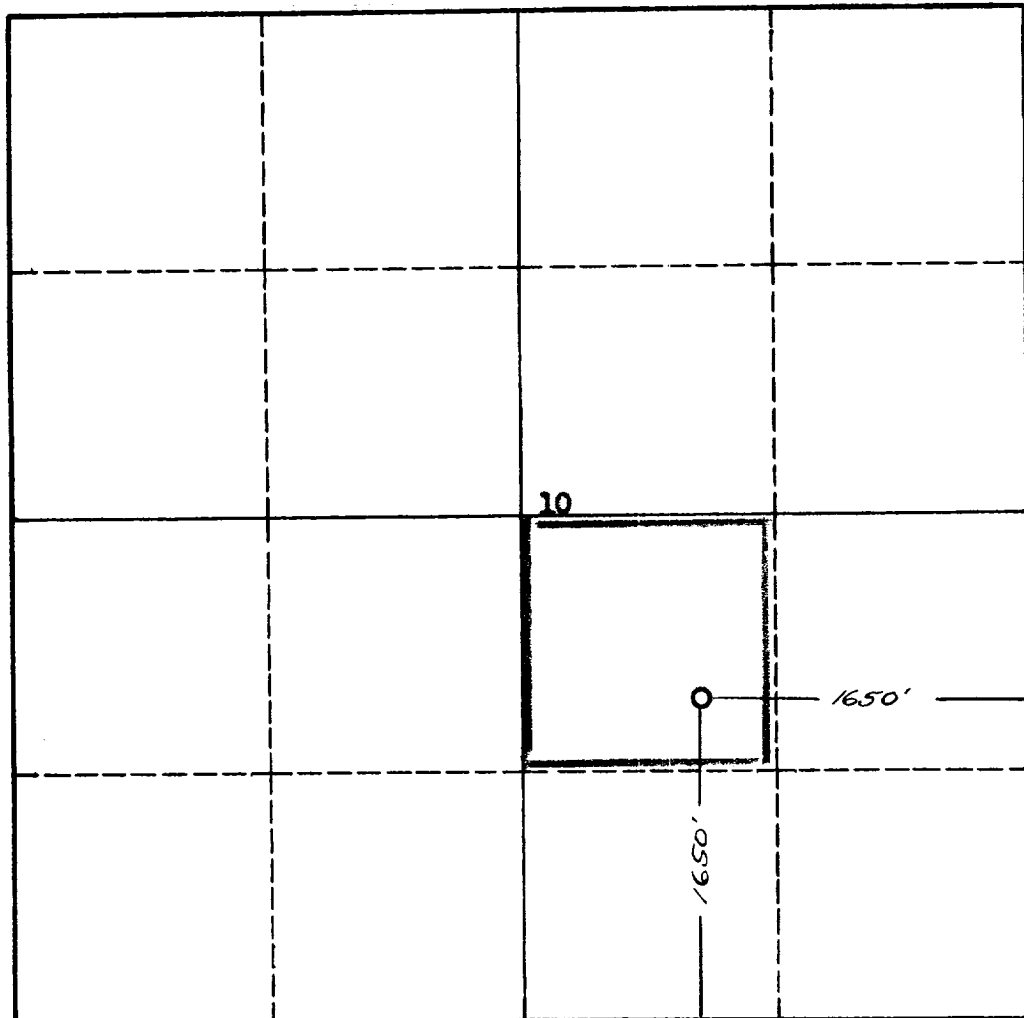
