To run an electric log and if productive, to set approximately 3400' of 4 1/2" new casing and cement with approximately 100 sacks. To perforate the Pictured Cliffs pay zone and sand-water frac same. To run approximately 3350' of 1" EUE tubing and to complete and produce as a Pictured Cliffs gas producer. To comply with the rules and regulations of the U.S.G.S. and the New Mexico Oil And Gas Commission.

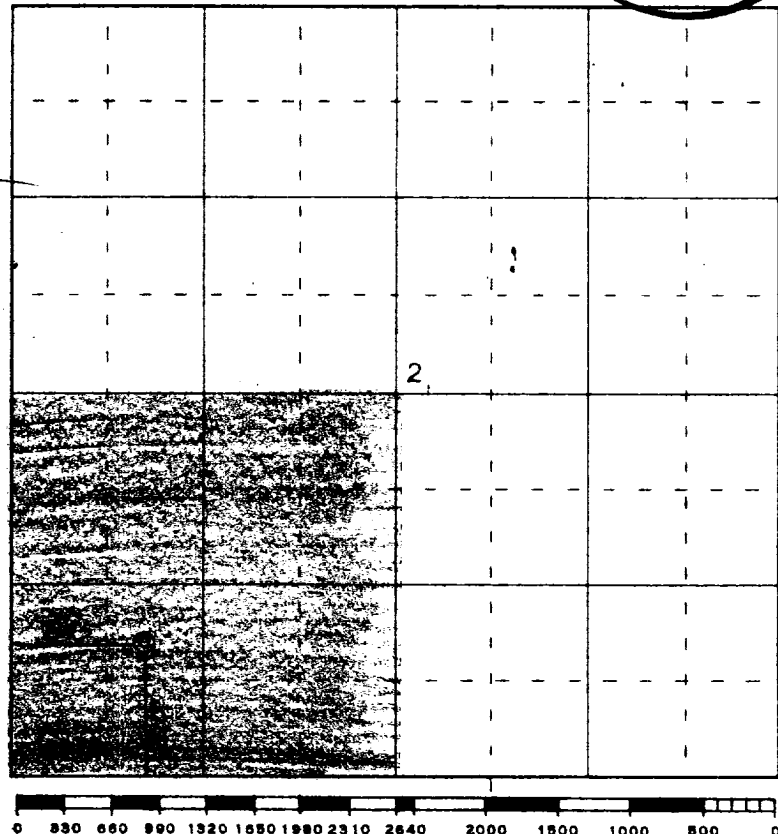
