Spud well on 12-7-01 @ 2:30 PM. Drilled 12-1/4 hole to 412' KB. Ran 9 joints 8-5/8, J-55, 24# STC casing - set @ 390.13' KB. Cemented with 315 sx Class "B" cement, 3% cc, 1/2# celloflake. Displace with 23.35 bbls water. Plug down @ 7:30 PM. Circulate 20 bbls cement to surface. Drilled 7-7/8 to 5987' KB. TD reached @ 5:30 PM on 12-19-01. Ran Halliburton High Resolution Induction Log and Spectral Density Log.. Ran 143-joints 4-1/2, 11.6# J-55 casing- set @ 6045' KB. Stage tool set @ 2654' KB. Cemented first stage w/650 sx 65/35 POZ 6% gel, 1/4# Flocele, 10# Gilsonite, 1% CC and 50 sx Class "H", .5% Halad, 9-5# Gilsonite, 1/4# Flocele, 1% CC. Bump plug to 2000 PSI and open stage tool. Circulate 4 hrs and 32 bbls cement to surface. Cement 2nd stage w/540 sx 65/35 POZ, 6% Gel, 1/4# Flocele, 10# Gilsonite, 1% CC and 50 sx Class "H", .5% Halad, 9-5# Gilsonite, 1/4# Flocele, 1% CC. Drop plug and close stage tool w/4700 PSI - plug held. Circulate 100 bbl cement to surface. Rig down cementers. Set slips. Cut off casing. Release rig.
