CURRENT OPEN PERTURATIONS ARE IN THE GALLUP B AT 4,278 TO 4,548.

This proposal is to set a <sup>46"</sup> cast iron bridge plug above the Gallup "B" at 4,220' and perforate and frac the Gallup "A" at 4,010' to 4,020' and 4,130 to 4,140'. If frac design will allow, then we may also perforate and frac the Gallup "A" at 3,718' to 3,726'.

The estimated date of starting this proposed work and/or the other work proposed on the SAN ISIDRO 12-2, 14-4, 13-11, 3-16, 5-14, and 1-16 is on or before July 26, 2002. The same rig will be used for all the work on all of these wells.
