Enclosed are your Applications for Permit to Drill (APD's) the following wells:

1. No. 3 Jicarilla 452, NW/4NE/4 section 6, T. 29 N., R. 3 W., Rio Arriba County, New Mexico, Jicarilla Contract 452
2. No. 28 Natani Com, NE/4SW/4 section 3, T. 21 N., R. 6 W., Sandoval County, New Mexico, lease NM-34582
3. No. 29 Natani Com, NW/4SE/4 section 3, T. 21 N., R. 6 W., Sandoval County, New Mexico, lease NM-17007

As discussed with Eileen Hare of your company on July 17, 1990, the subject APD's are rescinded and returned due to drilling not being commenced within one year of the approval date.

You are required to request surface rehabilitation instructions from this office if construction activities occurred on the referenced drill sites. If this office does not receive comment within 30 days, we will presume that no construction occurred and proceed accordingly. Later discovery that construction activities have in fact occurred, may result in assessment of liquidated damages.
