Started plugging operations 1-21-67. Plug No.1 was 320 sacks of cement cement from 2400' to 2750' in 8 3/4" hole. Plug No.2 was 35 sacks of cement cement from 290' to 350' surface casing of 10 3/4" OD had been set at 274'. Thus Plug No.2 was 75' outside and 24' inside the surface casing. Plug No.3 was 10 sacks of cement cement from 11' to 32' inside the surface casing. Mud of 9.24/gal weight was left between the plugs. A dry hole marker has been set but the location has not been cleaned up as yet.
