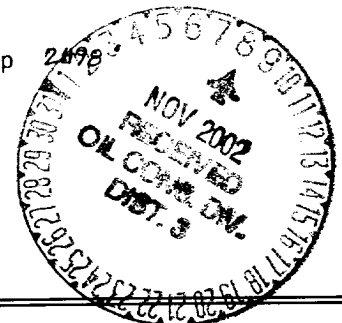

  2. Spot Class "B" cement from CIBP to 4,144'.
  3. Perforate casing and spot Class "B" plug inside and outside casing from 1,800'-1,800'. MV top 1,850'.
  4. Spot Class "B" plug 904'-1,150' to cover PC & FC. FC top 944'.
  5. Spot Class "B" plug from 475' surface.
  6. Set dry hole market and perform surface remediation.
