Moved in & rigged up Four Corners Drilling Rig #14. Spudded a 12 1/2" hole @ 9:30 PM 8-19-95. Drilled to 240'. Ran 5 jts. 8-5/8" OD, 24#, 8 Rd. ST&C, L.S. casing (T.E. 220') set @ 232' RKB. Cemented with 150 sx class "B" plus 2% CaCl₂ (total cement slurry 177 cu.ft.). Circulate 5 bbls cement to surface. P.O.B. @ 3:15 AM 8/20/95.

Nipple up and pressure test surface casing and BOP 600 psi - held OK.
