

Drill to 1525'. Run 4-1/2" 10.5 lb. casing at 1524'. Cement with 123 cu. ft. 2% Lodense containing 1/4#/sk celloflake. Follow with 118 cu. ft. class "B" cement containing 1/4#/sk celloflake. Circulate 4 bbls cement to surface. Total 241 cu. ft. slurry. Job complete 6/30/99.
