RU pulling unit. RU wireline, set CIPB @ 6721'; dumped 4 sx cement, spot mud from 6673' to 5593'. Set CIBP @ 5593', dumped 4 sx cement. Spot mud from 5538' to 4839'. Pulled up to 4839' pumped 75 sx Class B, pulled up to 4192' pumped 75 sx Class B, pulled up to 3543', pumped 75 sx Class B heat, displaced with 15 bbl mud. RIH and perforate @ 2446' w/4 shots. Set 5½" cement retainer @ 2352'. Pumped 300 sx Class B w/fluid loss thru retainer, stung out of retainer pumped 118 sx, calculated TOC @ 1385'. Casing leak @ 560'. Pumped 165 sx cement down 5½" casing and cement circulated out surface casing. Cut off surface and production casing, topped off w/cement. Welded on cap & installed P&A marker. Clean location. Will seed location.

GENERAL INSTRUCTIONS

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

SPECIFIC INSTRUCTIONS
