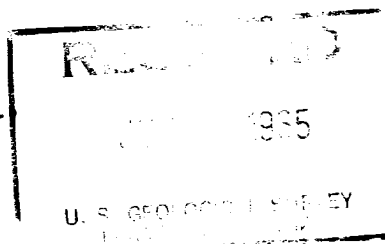

Instructions

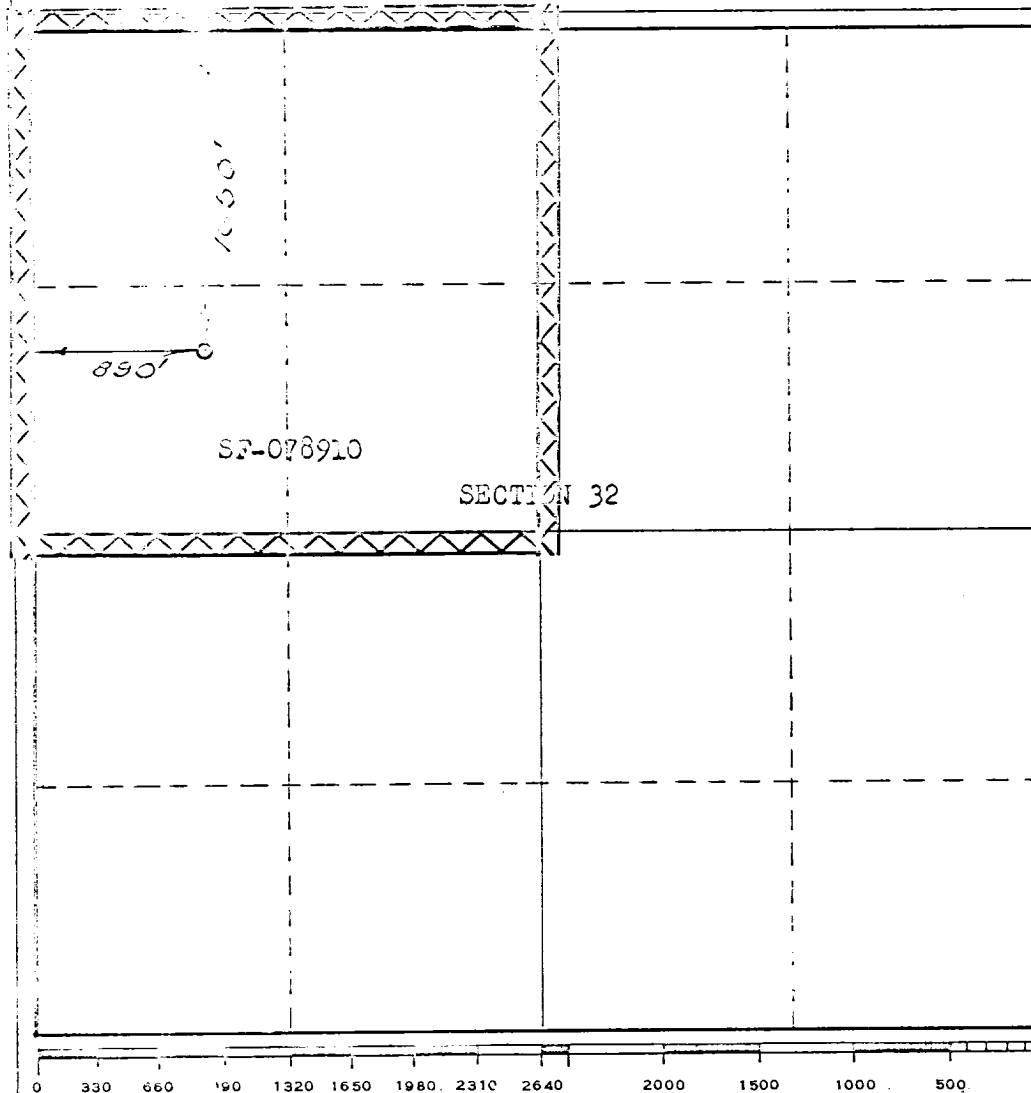
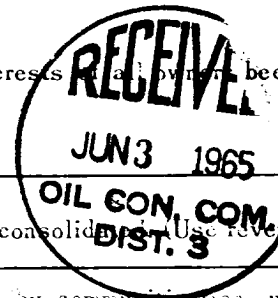
