We propose to drill the subject well to an estimated depth of 5925' to test the Gallup formation. Approximately 300' of 9 5/8" casing will be run and cemented to surface. If commercial production is encountered, a string of production casing will be run and cemented and the well completed.

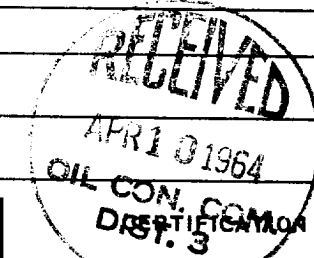
