DETAILS OF WORK

We propose to drill the subject well to an estimated depth of 6950' to test the Dakota formation. Approximately 300' of 8 5/8" surface casing will be run and cemented to surface. If commercial production is encountered, the well will be completed following running 5 1/2" production casing and cementing as follows:
Dakota and Gallup formations will be cemented thru the casing shoe.
Mesa Verde and Pictured Cliffs formation will be cemented thru a stage collar @ approximately 4700'.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

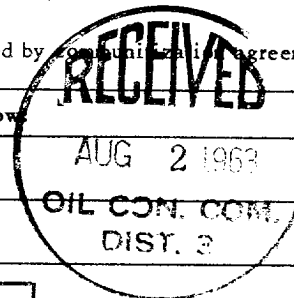

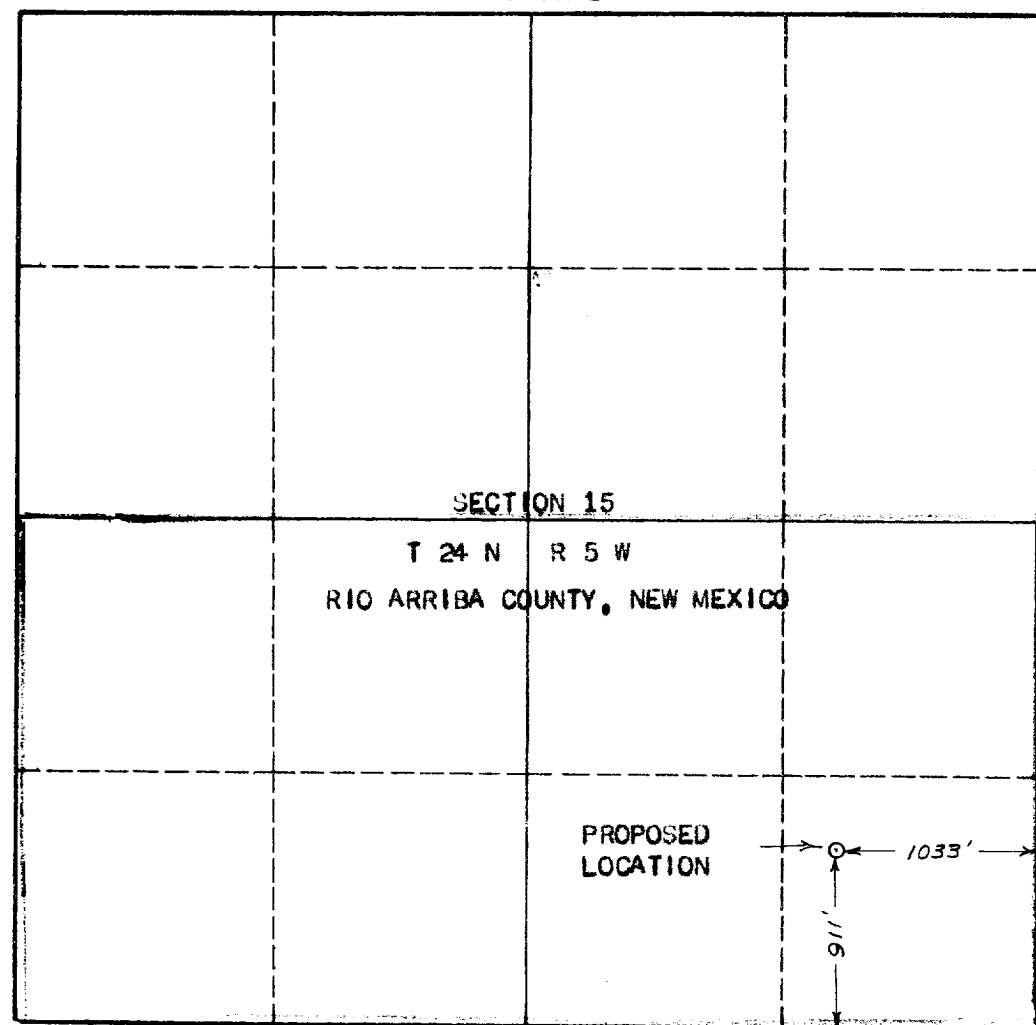
