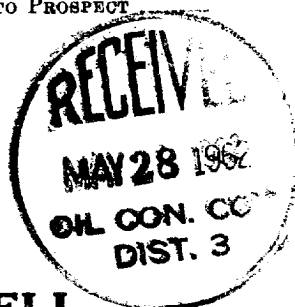

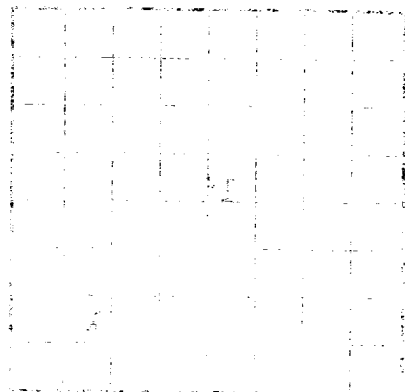

Letter to Sundry Notice forms previously submitted.
