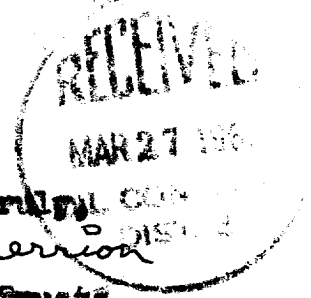
Reference is made to your Administrative Order NFO-504 of February 16, 1961, wherein you granted authority to flare casinghead gas from the Merrion Trusts #1 Edna until April 1, 1961.

C. has advised by phone today that he has today airmailed a notice of acceptance of the filing. Furthermore, the officials of Four Way Construction Company, to which El Paso let the contract for pipeline construction have advised by phone today that they hope to complete the gas line by April 10, 1961 weather conditions permitting.
