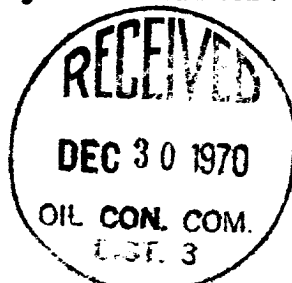

It is intended to plug and abandon this well in the following manner:

1. Set 100' cement plug from 5850 - TD, across perforations.
2. Set 100' cement plug, inside casing, 3930'-4030', across Mesa Verde.
3. Set 175' plug, inside casing, 2365'-2540', across Pictured Cliffs.
4. Perforate at 2050'.
5. Set 275' cement plug, inside and outside casing, 1775-2050', across Ojo Alamo.
6. Set 5 sacks cement in annulus, and 10 sacks cement in 4" casing with dry hole marker.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
