Pursuant to your letter of February 7th and my telephone conversation with you of February 26th, attached please find tabulation of casing pressures on the Pictured Cliffs and on the Gallup side of the Edna #2 well for the period before, during, and after the shut in period for the Devil's Fork-Gallup reservoir in July and August of 1962.

The Gallup side of this well has always had a comparatively low GOR for Devil's Fork-Gallup wells. The Pictured Cliffs side has never made appreciable liquids, and those liquids produced from the Pictured Cliffs are clear in color.

A packer leakage test was submitted in June of 1961 upon completion of the well. The Pictured Cliffs first started producing in January of 1962. The 1963 packer leakage test is scheduled for May of 1963.

It is requested that the attached data, together with the packer leakage test submitted upon completion of this well, be accepted for the 1962 test.

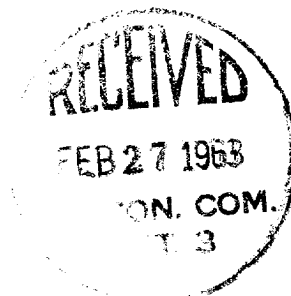

Pursuant to your letter of February 7th and my telephone conversation with you of February 26th, attached please find tabulation of casing pressures on the Pictured Cliffs and on the Gallup side of the Edna #2 well for the period before, during, and after the shut in period for the Devil's Fork-Gallup reservoir in July and August of 1962.

The Gallup side of this well has always had a comparatively low GOR for Devil's Fork-Gallup wells. The Pictured Cliffs side has never made appreciable liquids, and those liquids produced from the Pictured Cliffs are clear in color.

A packer leakage test was submitted in June of 1961 upon completion of the well. The Pictured Cliffs first started producing in January of 1962. The 1963 packer leakage test is scheduled for May of 1963.
