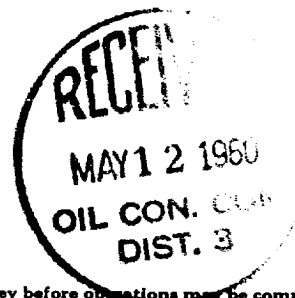

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

Spudded 12-1/4" hole May 8, 1960 and drilled to 251'. Set 8-5/8" casing at 251' with 200 sacks cement containing 2 percent calcium chloride. Circulated cement. After waiting on cement, tested 8-5/8" casing with 500 psi for 30 minutes which held with no indication of pressure drop. Reduced hole to 7-7/8" at 253' and resumed drilling operations.
