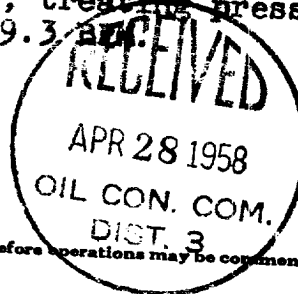

DETAILS OF WORK

3-4-58 TD 2769'. Cleaned out to 2755'. Perforated 2673-2695' and 2717-2746' with 4 shots per foot. Sandfraced with 28,300 gallons water and 30,000# sand, flushed with 2,700 gallons water. Dropped 110 rubber balls during treatment. Breakdown pressure 3000#, treating pressure 1350-1750#, average injection rate 59.3 bbl/hr.

3-5-58 After 24 hours flowing 131 MCF/day.
