Plugged and abandoned well as follows:

1. Placed 100' cement plug 5850 to C.O.T.D., across perforations.
2. Placed 100' cement plug, inside casing, 3900' - 4000' across top of Mesa Verde.
3. Perforate at 2500'.
4. Set 150' cement plug, inside and outside casing, 2350- - 2500', across Pictured Cliffs.
5. Perforated at 1950'.
6. Set 200' cement plug, inside and outside casing, 1750' - 1950', across Ojo Alamo.
7. Placed 5 sack cement in annulus and 10 sacks installed in the top of 4 1/2" casing @ 450' and dry hole marker installed.
8. Cleaned up location

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
