DETAILS OF WORK

It is intended to drill a well thru the Gallup Formation using rotary tools and mud circulation. Possible productive intervals will be perforated and sand oil fractured. A two-stage collar will be set 100' below bottom of Picture Cliffs and this zone cemented off.

8-5/8" at 173' with 150 sacks cement circulated to surface.
4-1/2" at 5850' with 150 sacks cement--first stage; 100 sacks cement--second stage. Estimated top of cement first stage 4680', second stage 2000'.

The W/2 NE/4 of Section 9 is dedicated to this well.

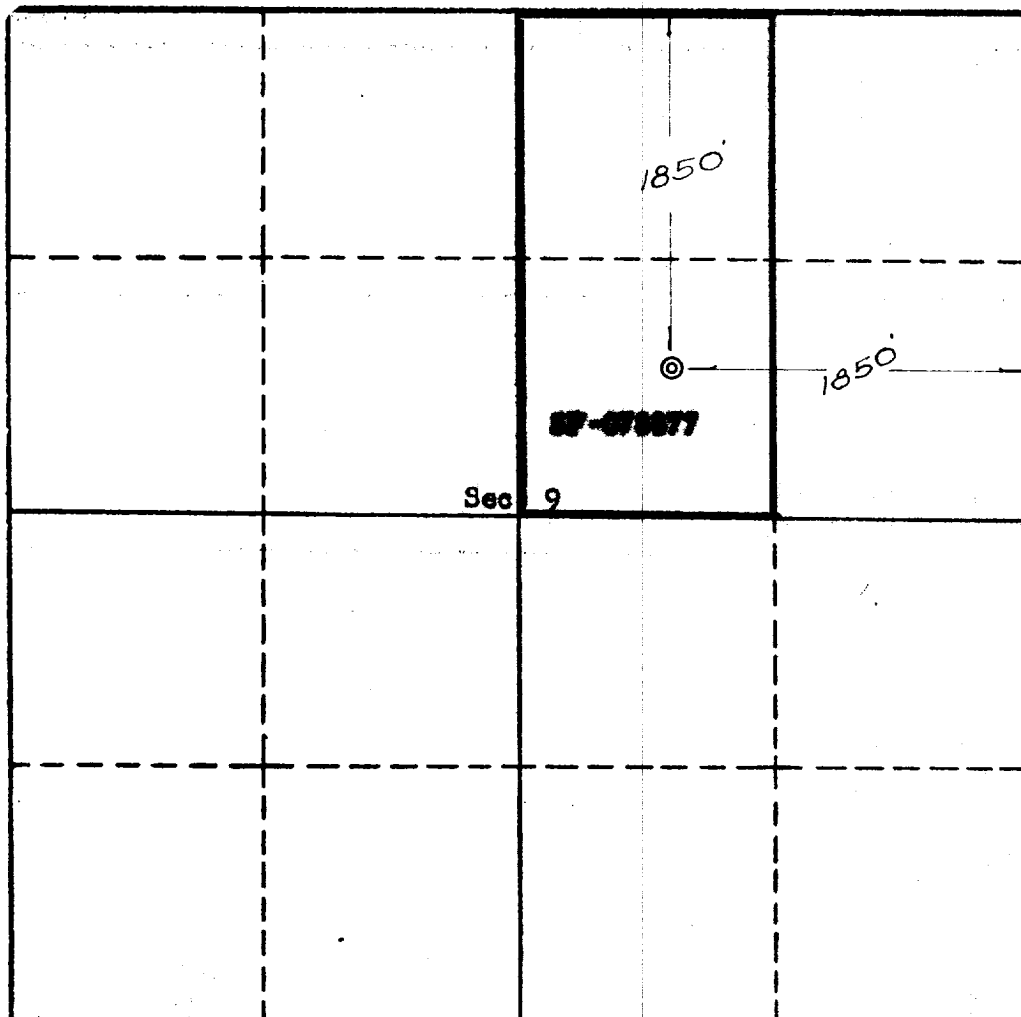
