9-2-73 TD 2576'. Ran 84 joints 2 7/8", 6.4#, J-55 production casing, 2566' set at 2576'. Baffle set at 2565'. Cemented with 249 cu. ft. cement. WOC 18 hours. Top of cement at 1525'.

9-28-73 Tested casing, held 4000#. PBTD 2565'. Perforated 2466-78' and 2490-98' with 16 shots per zone. Frac'd with 29,000# 10/20 sand and 30,800 gallons treated water. Dropped one set of 16 balls. Flushed with 620 gallons water.
