10 3/4 casing was cemented to 178 ft below top of rotary table w/100 sacks regular cement on April 16 and after 36 hrs drilling was resumed. Both casing and cement were tested with 750 lbs pressure with no leaks. Rotaru table is 128 2" above ground level.
