Gentlemen:

Reference is made to your application for approval of a 174.21-acre non-standard gas proration unit in the South Blanco Pictured Cliffs Gas Pool consisting of the following acreage:

Township 24 North, Range 3 West
Lots 3 & 4 and 1/2 NW/4 of Section
5

It is understood that this unit is to be ascribed to your Clark Well No. 3, located 1730 feet from the North line and 1550 feet from the West line and in the SE/4 NW/4 of Section 5, Township 24 North, Range 3 West, NMPM, Rio Arriba County, New Mexico.

Inasmuch as you enclosed waivers from the offset operators agreeing to the formation of the proposed unit, it is possible for immediate approval to be granted. Therefore, by authority granted me under provisions of Rule 6, Section (B)-5 of the Special Rules and Regulations of the South Blanco Pictured Cliffs Gas Pool, as set forth in Order R-865-C, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 174.21 acres.
