DETAILS OF WORK

It is our intention to drill Well No. 17 to approximately 4400' to test the Gallup formation. Our casing program is as follows:

300' of 10-3/4" OD 32.75# K-40 casing with 250 sacks regular cement, to be circulated.

4400' of 5-1/2" OD 15.5# J-55 casing with 450 sacks regular cement.

The designated drilling unit is the SE 1/4 NW 1/4 of Section 5-24N-SW, Rio Arriba County, New Mexico.

If necessary, NW tool to be run to cover FC with cement.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

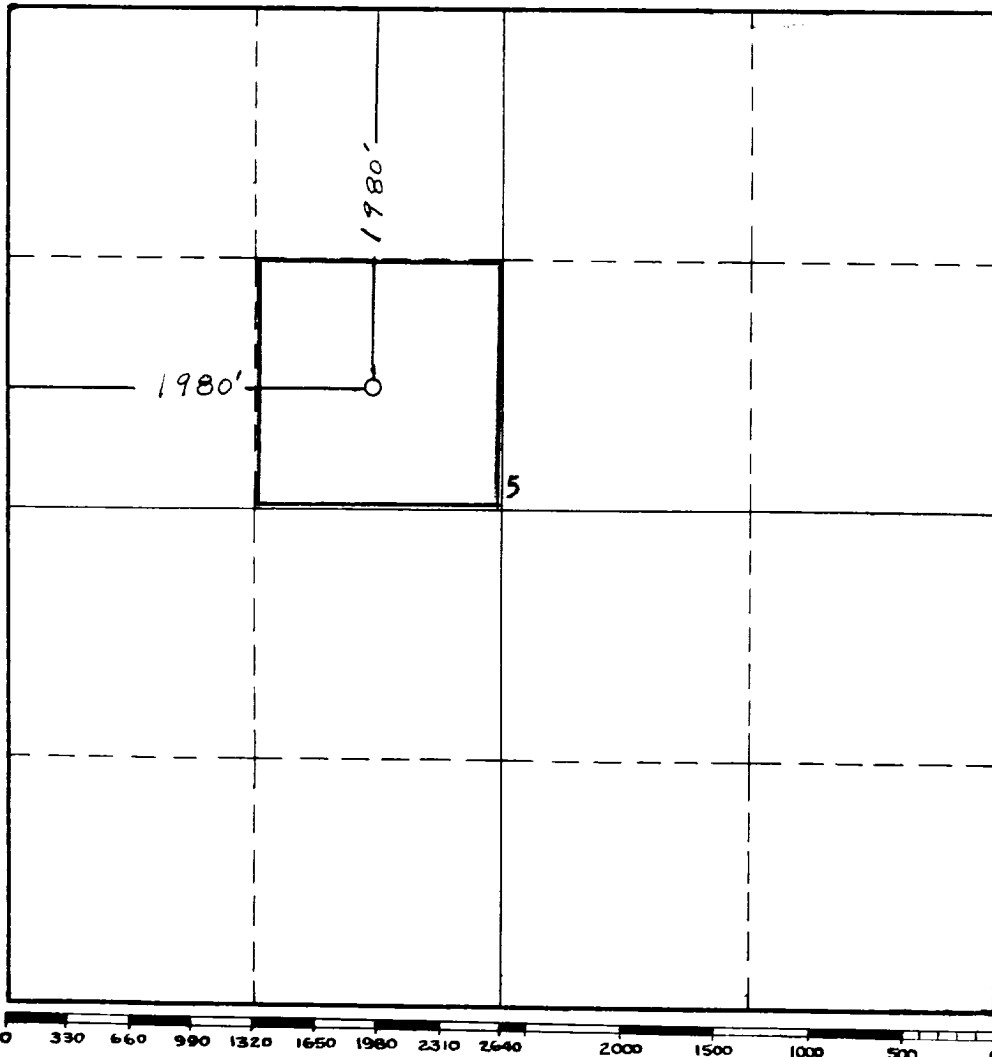
