6400' of 5-1/2" OD 15.5# J-55 casing with 490 sacks regular cement.

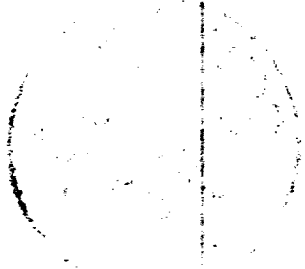
The designated drilling unit is the NE 1/4 - NE 1/4 of Section 9 - 24E - 3N, Rio Arriba County, New Mexico.

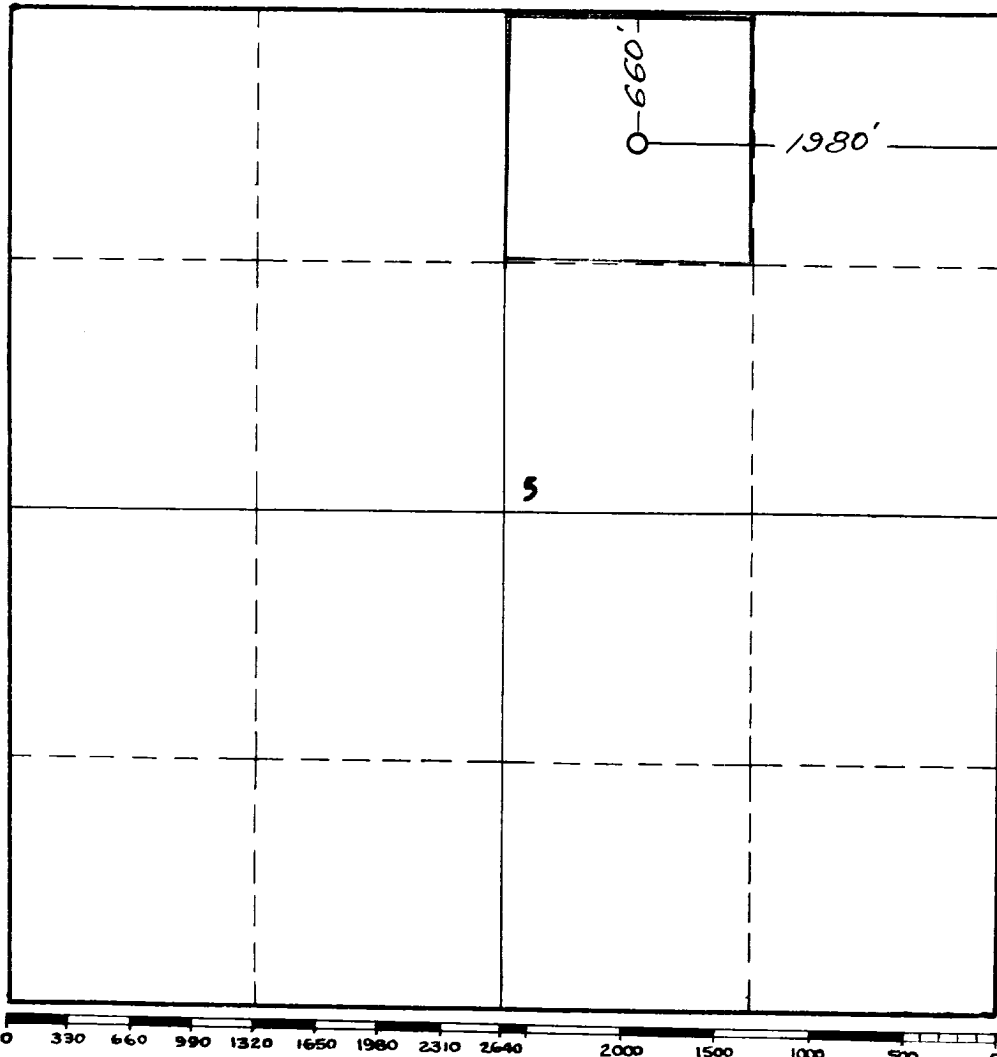
