WORK DONE: RU Aztec Well Service, ND WH & NU BOP. RIH w/3-7/8" bit & 4 1/2" csg scraper to 3000'. POOH w/bit & csg scraper. RIH w/4 1/2" cement retainer, set @ 3013'. Tested tbg to 1500' psi - o.k. Stung-out & back into retainer. Establish rate of 2 BPM @ 800 psi w/wtr. Pumped 63 sx Class B cmt mixed @ 15.6#/gal slurry weight thru cmt retainer @ 2 BPM, 400 psi. Stung-out retainer & pumped 69.5 sx above retainer, pulled tbg to 2034' & pumped 17 bbl mud that exceeded BLM requirement, finished pulling 2-3/8" tbg. SION. Est. TOC @ 2080', est top of mud @ 1000'. (NOTE: The increased amount of cmt retainer was at the BLM's request). RU. RIH & tagged TOC @ 2173', pulled up & perforated csg @ 1000' w/4 shots .5" EHD. RD wireline, RIH w/tbg & set Baker 4 1/2" with 8-5/8" open, pumped 6 bbl, no sign of circulation. Pumped down 4 1/2" with 8-5/8" open, would not circulate. Pumped down tbg thru retainer, well started circulating up 4 1/2" csg, pumped 71.5 sx below retainer. Lost returns at end of job, stung-out of retainer & dumped 62' of cement on top of retainer. Pulled tbg & pumped 71.5 sx down 4 1/2" csg. SD. Cut off 8-5/8" & 4 1/2" 4' below ground level, both csg strings full of cement. Weld on plate with P&A marker 3' above ground level as per BLM requirements. BLM inspector on location for complete job. RD & move off location. (NOTE: Location was seeded as required by BLM). P&A Date: 6-19-91.

GENERAL INSTRUCTIONS
