6400' of 5-1/2" OD 15.5# J-55 casing with 450 sacks regular cement.

The designated drilling unit is the SE/4-NR/4 of Section 31-25N-5W, Rio Arriba County, New Mexico

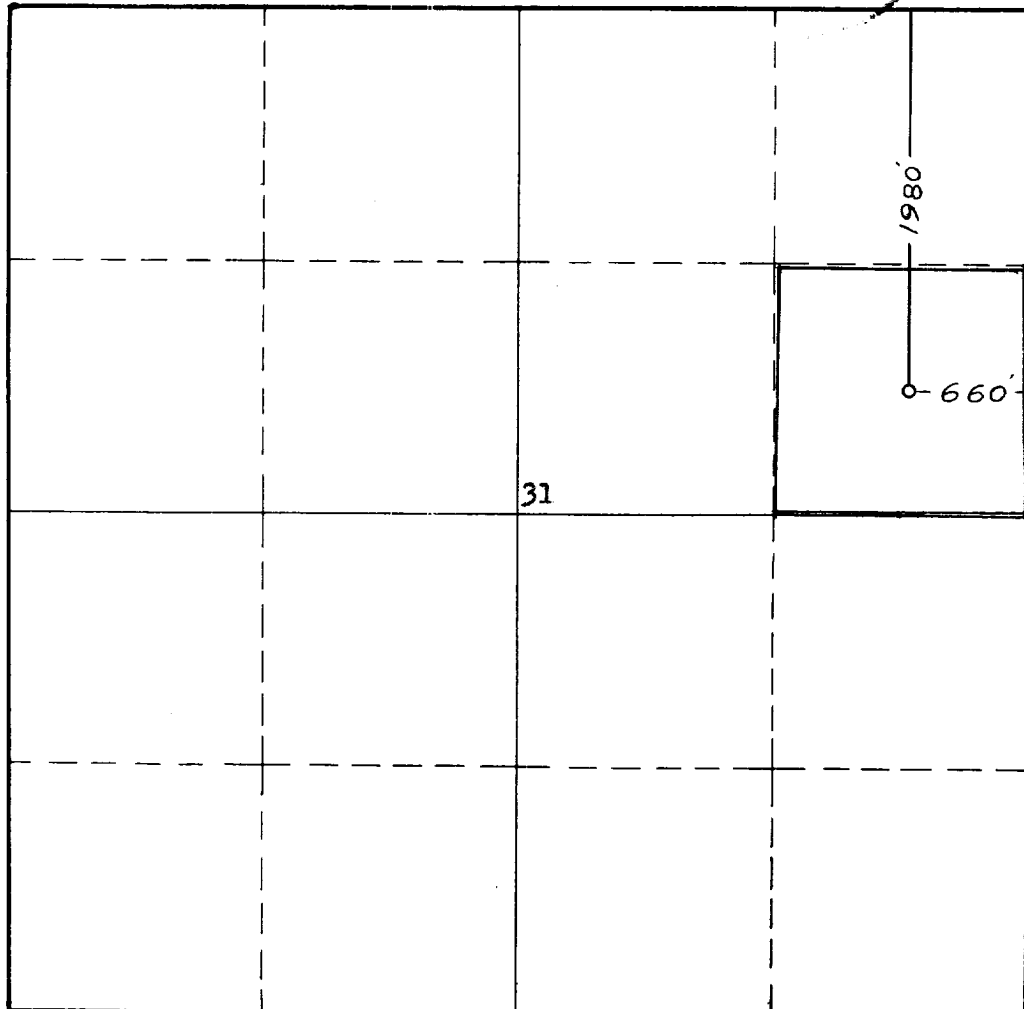
