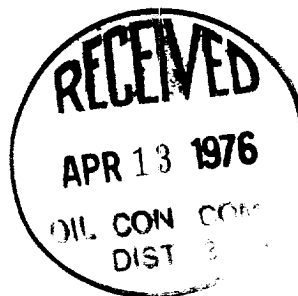

This well was proposed for plugging and abandonment. We are now making a study of this lease and the adjoining Jicarilla "G" lease for pay behind pipe. Tentatively, we are considering an attempt at Mesoverde production on Skelly's Jicarilla "G" lease but have not completed the study. We plan to hold Jicarilla "C" No. 20 for possible recompletion in a zone behind pipe, depending on the results of our study and subsequent work on other wells.

Instructions
