3900' of 5-1/2" OD 14# casing, cemented with 200 sacks cement.

The designated drilling unit is the SW 1/4-SW 1/4 of Section 29-25N-3W, Rio Arriba County, New Mexico.

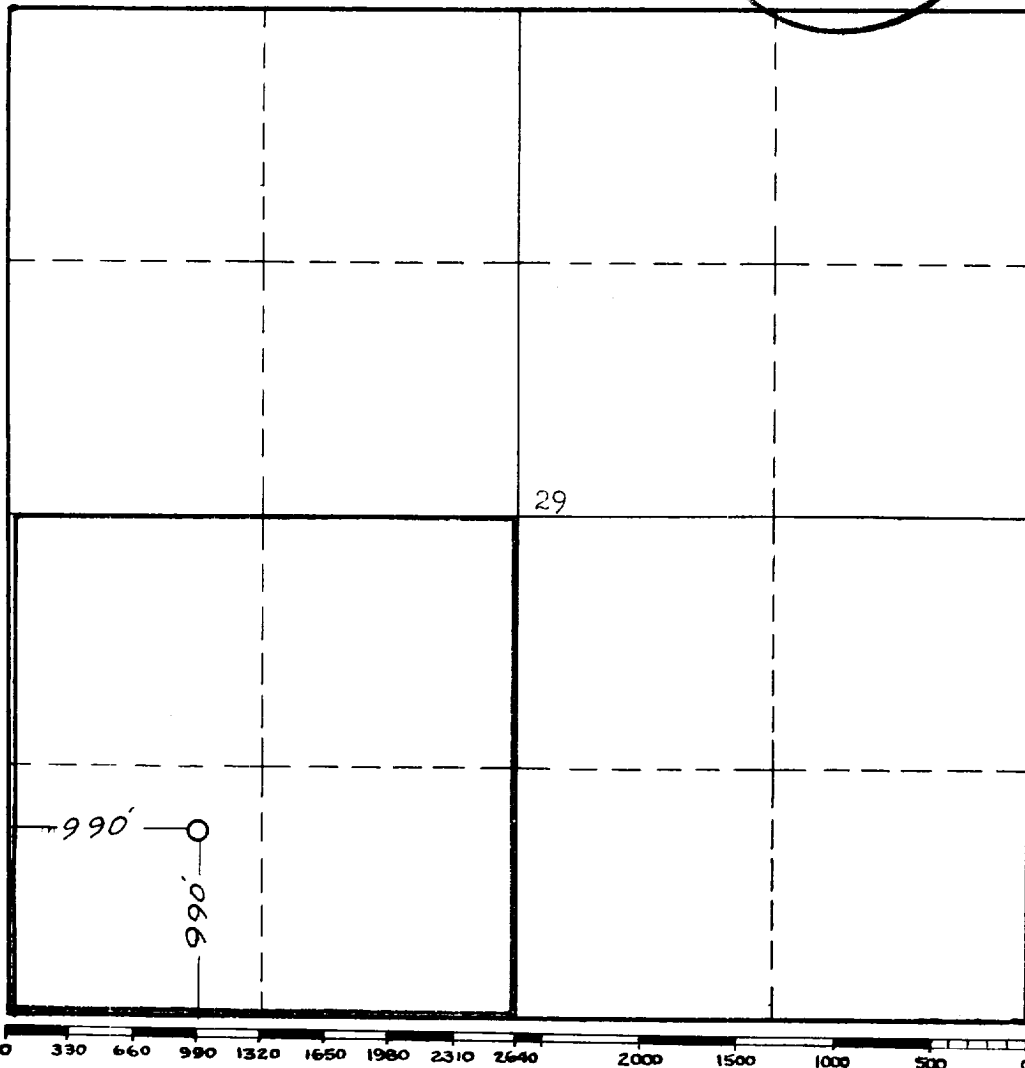
