DETAILS OF WORK

4000' T.D. **3981' DOD**

Run 95 jts 5-1/2" OD 15.5# casing, set a 3989' & cemented w/350 lbs reg. cement mixed 2% gal. Pumped plug to 3945' w/max. pump pressure of 800#. W.C.G. Run temperature survey & found top of cement outside of 5-1/2" casing @ 2105' or 845' fill. Tested casing w/1000# before & after drilling cement & plug, held OK. Continuing with completion work. Drill out to 3981', perforate LaVentana Section, sand-free & test.
