It is our intention to drill Well No. 19 to approximately 3900' to test the Chaco formation. Our casing program is as follows:

300' of 10-3/4" OD 32.75# J-40 casing with 250 sacks regular cement, to be circulated.

3900' of 8-1/2" OD 15.5# J-55 casing with 450 sacks regular cement.

The designated drilling unit is the SE 1/4 of Section 27-29N-9W, Rio Arriba County, New Mexico.




