DETAILS OF WORK

It is our intention to drill Well No. 25 to approximately 6400' to test the Gallup formation. Our casing program is as follows:

300' of 10-3/4" OD 32.75# N-40 casing with 300 sacks of regular cement, to be circulated.

6400' of 9 1/2" OD 15.5# J-55 casing with 750 sacks of regular cement, in 2 stages. DV tool to be run to cover PC with cement.

The designated drilling unit is the NW/4-SW/4 of Section 27-25N-5W, Rio Arriba County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

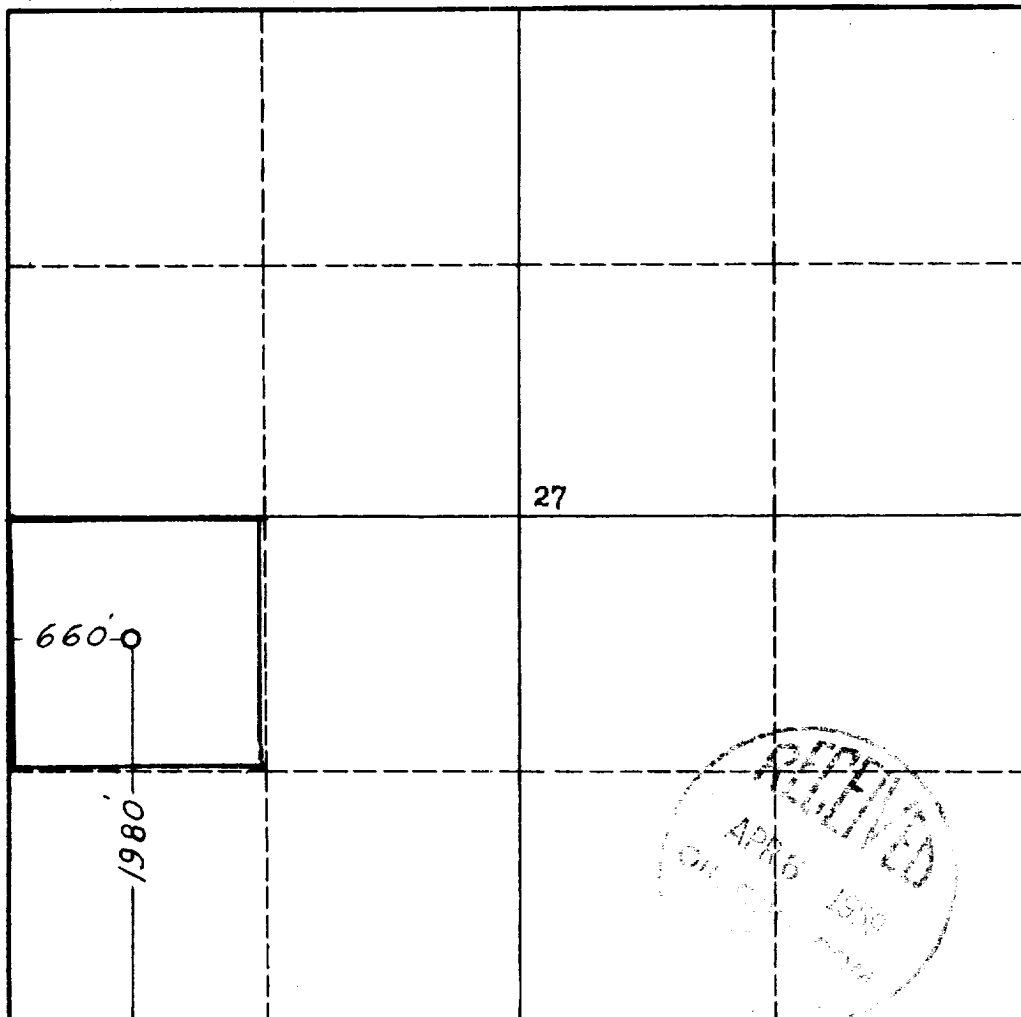
